



1. To manage trust funds and collect and recover the interest, income and profits, thereof, and to pay bear out the expenses of collection and other out going if any.
2. The trustees shall have all powers specifically Confirmed to do things as may be required for the proper conduct of the trust and in the interest of the trust, whenever such powers are not specifically confined.
3. The trustees shall be entitled from to time to open maintain and operate bank account, or accounts, in the name of the trust or in the name of the school or schools or institutions at such banks or banks as they may from time to time decide and may at any time pay or cause to be paid any monies forming part of the trust fund of school funds, or the income thereof to the credit of any such account or accounts either by way of fixed or current account or any other account, any such account shall be operated, open individually by managing trustee or joint managing trustee, or by any two of the other trustees.
4. 5. The trustees are bound by all the liabilities, costs, upon them under the Indian trust act 1882 except to extent of the powers specifically confirmed and these presents.
6. 9. The trustees may from time to time appoint any Accountant clerk and any other officials and employees or teachers or the trustees may deem expedient and fix and pay their remuneration out of the trust fund or the income thereof.
10. All the funds of the trust shall be dealt with under section 13 of the income tax act 1961.
11.
